

The Governing Body at Jacksdale Primary and Nursery School is made up of members of the local and school community, all acting on a voluntary basis. We have a mixture of local authority, parent and staff governors as well as members who have been co-opted from the local community. Each member brings a different perspective and set of skills to the governing body.



The Governing Body are responsible for ensuring that the school is run as well as it can be to promote pupil achievement. We are constantly striving to make sure every child reaches their full potential whilst at our school. This embodies the school's ethos of 'every individual making a valuable contribution to school life so that they are the best that they can be'.

We provide strategic management, act as critical friends and ensure accountability. We work very closely with Miss Brockerton, the Head Teacher, who is responsible for the day-to-day management of the school.

We are required to have a strong focus on three core strategic functions:

1. Ensuring clarity of vision, ethos and strategic direction;
2. Holding the head teacher to account for the educational performance of the school and its children, and the appraisal of staff;
3. Overseeing the financial performance of the school and making sure its money is well spent.

When a school is inspected by Ofsted, its governing body will be required to show evidence that governors conform with their three core functions. We also make this information available on this website through our annual statement.

2 parent governors (who volunteer or are elected by parents and carers of children at the school - in the case of more volunteers than positions available);

5 co-opted governors (who are appointed by the governing body based on their skills and experience)

1 Local Authority governor (who is nominated by the Local Authority and appointed by the governing body based on his/her skills and experience);

1 staff governor (who is elected by staff at the school);

As well as attending formal governing body meetings, we all play an active part within school and attend governor training sessions on various educational issues to help us in our role. Our Governors

The governors are supported in the role by a Clerk to Governors who is **Mrs Jennifer Kirkwood**.

We meet at least 6 times per year for formal meetings in the form of *Committee Meetings* or *Full Governors meetings* and also meet to attend a range of training throughout the year. We also hold separate *Standards Committee meetings* to examine the progress data in Reading, Writing and Maths in each year group.

The Head Teacher, the Chair of Governors and the Vice-chair of governors also meet regularly to discuss any relevant issues and to monitor the progress of the school action plan.
